**SUBJECT:** Fraud, Waste and Abuse

Under the HealthChoices program, AmeriHealth Caritas Pennsylvania and AmeriHealth Caritas Northeast (the Plan) receive state and federal funding for payment of services provided to our members. In accepting claims payment from the Plan, health care providers are receiving state and federal program funds, and are therefore subject to all applicable federal and/or state laws and regulations relating to this program. Violations of these laws and regulations may be considered fraud or abuse against the Medical Assistance program.

Some examples of provider fraud, waste or abuse include but are not limited to:

- Billing for services not rendered or not medically necessary.
- Submitting false information to obtain authorization to furnish services or items to Medicaid recipients.
- Prescribing items or referring services which are not medically necessary.
- Misrepresenting the services rendered.
- Submitting a claim for provider services on behalf of an individual that is unlicensed, or has been excluded from participation in the Medicare and Medicaid programs.
- Retaining Medicaid funds that were improperly paid.
- Billing Medicaid recipients for covered services.
- Failure to perform services required under a capitated contractual arrangement.
